- 2.Please note that the Assessment schedule may change and we reserve the right to cancel courses if not enough candidates register.
- 3. You are not required to make use of any tools during the Assessment. Testing instruments will be supplied by the Assessment Centre. You may however, bring your own testing instruments, should you so wish. You will be required to bring the latest edition of the SANS regulation book SANS 10142-1 (2020, edition 3).
- 4. Candidates must wear long pants and closed shoes.
- 5. Candidates provide own meals. There is a restaurant/take-away for your convenience near the Assessment Centre. Only coffee and tea will be provided.
- 6.After being found competent at the final Assessment, your completed Portfolio of Evidence will be moderated by EWSETA. Only then will you receive a statement of results from EWSETA. With your statement of results and your personal documents, you can apply at the Department of Labour for the registered person license.
- 7.If you are declared not yet competent on any of the Unit Standards, that Unit Standard will need to be re-assessed.
- 8, All course correspondence and Assessment will be done in English.

TERMS AND CONDITIONS

- 1. The course date is a provisional date. The non-refundable deposit of R 4000-00 must be paid to secure your booking for the course. The balance of R 3400-00 is payable either into the bank account by the Saturday before the course or in cash on the first day of the course.
- 2.Please note that it is your responsibility to ensure that you meet the registration criteria of Department of Labour to be registered as a registered person (wireman's license). WCC cannot be held responsible if you do not meet the criteria.
- 3. You will be trained for 3 Phase regardless of your qualifications but cannot apply for 3 Phase wireman's licence if you do not have installation rules paper 1 and paper 2 and at least N3.
- 4. You will be expected by the Department of Labour to produce a letter from WCC Assessment that confirms you are eligible for a Single Phase Wireman's License. This letter will be issued by wcc at a fee of R1500. Alternatively wait to apply with the Department of Labor until you have installation rules paper one and two then you will not need the letter.
- 5.Get a chance to get R200 when you refer an applicant and they enroll. Simply ask them to mention on the application form that they were referred by you (name, surname and telephone number).
- 6. Attendance during the registered time is mandatory, once a student has started attending the course on the scheduled course dates and attendance can no longer be fulfilled, a new registration will be required and all the previous funds forfeited. i.e. in case of an emergency the student should provide relevant proof and will be instructed by the administrators on what the next step will be
- 7. Any tools signed out by students will remain the property of WCC Assessment. However should any of the tools be damaged or go missing, while in your care, you will beheld liable to replace the respective tools.
- 8. Should a student be found Not Yet Competent (NYC), you will be required to attend a mandatory file revie w followed by a scheduled of a Re-Assessment, Re-assessment is R1500.
- 9. All candidates have a 1 year period in which to submit their outstanding documents, if a student fails to submit these *Kindly note that there is a shift in the industry where training programs that are accredited by SETA's are being handed over to QCTO. EWSETA is our current accrediting body for this training program (Wireman License). They are responsible for the external moderation of all student files as well as releasing of statements of results which is what is used at the Department of Labor when you apply for the physical wireman license. EWSETA is in the process of relinquishing these responsibilities to the QCTO and that process is currently underway, please note your application will be registered under the current EWSETA system as it is still open and changes haven't been finalized yet, however should the transition from EWSETA to QCTO be finalized before your eceive your statement of results we will ensure that you are registered on the



new upcoming QCTO system.
